CALL FOR SUBMISSIONS FOR SCMTA 2024 COMPOSER COMMISSIONING

Composers with connections to South Carolina are invited to apply for the South Carolina Music Teachers Association 2024 Commissioned Composer Award.

Benefits

1. The composer selected will receive a \$1500 cash prize (\$750 from SCMTA matched by MTNA).
2. The piece will be advanced to eligibility for the MTNA Distinguished Composer of the Year (\$5000 award).
3. Premiere performance at the SCMTA 2024 conference (October 31-November 2 Furman University)

Background of the Commission

Music Teachers National Association is dedicated to encouraging the creation of new works by American composers. MTNA annually assists its affiliated state associations in the generation and performance of new music through the national composer commissioning program. SCMTA, as the MTNA affiliated organization in South Carolina, annually commissions an American composer to write a new work which will premiere at its annual conference.

Composer Eligibility and Rules Requirements for 2024

The composer must currently reside or has lived in South Carolina.

Composers are *not* eligible who have, within the past three years, been commissioned by SCMTA or who have received the MTNA Distinguished Composer of the Year within the past three years.

Type of Composition to be Commissioned

This year, the board is seeking a creation that channels the eerie allure of South Carolina's rich ghost stories and folklore. We aim to encapsulate the mystery and intrigue of these tales into a captivating musical narrative.

South Carolina boasts a treasure trove of ghostly legends and folklore, weaving a tapestry of chilling encounters and mysterious occurrences stretching back centuries. From the haunted plantations of the Lowcountry to the ancient forests of the Upstate, South Carolina is alive with tales of the supernatural.

Just as the Carolina wren's song echoes through the Southeast, so too do these ghostly whispers reverberate through the corridors of our history. With each story encompassing its own unique blend of suspense, mystery, and Southern charm, there's ample inspiration to be found in the shadows of our past.

Requirements of the Composition and Premiere

1. Must feature piano.
2. The length should be not more than 15 minutes.
3. Lyrics, if any, must meet prior approval by the SCMTA board.
4. The composer is ultimately responsible for the performers, instrumentation, and audio recording at the premiere. (SCMTA will assist and coordinate where possible)

Application Process

The application consists of the following materials:

1. Commission proposal form (see below)
2. Current Curriculum Vitae (C.V.)
3. Two compositions (pdf scores with digital recordings or corresponding links to recordings) that best represent your body of work as a composer.

These three items should be sent to Alan Avant via email (avanta@winthrop.edu) no later than April 5, 2024. The committee will make an announcement around the end of April 2024. An official contract will then be signed by the commissioned composer and by SCMTA.

The deadline for the completed composition is October 1, 2024. For sake of performers at the premiere, an earlier time of completion is preferable. The composer is ultimately responsible to provide performers.

Composer Guidelines for the Commissioned Work and its Performance

1. The newly commissioned work is to be written for the express purpose of the SCMTA commission and may not have been previously written, in part or whole, before the SCMTA commissioning.
2. The commissioned composer will be selected by a committee of three, with final approval by the SCMTA board.
3. The commissioned composer will serve on the subsequent year's commissioning committee.
4. Although, SCMTA may be able to help facilitate connections to potential performers, the commissioned composer is ultimately responsible for securing the performers for the premiere.
5. If the state-commissioned composer is selected as the national Distinguished Composer of the Year, he or she receives \$5000. The composer must then provide performers for the national convention. Neither SCMTA nor MTNA provides travel expenses or honoraria for the performance at the national convention.
